DNOs must display that they have taken appropriate measures to aid and assist the dissemination of the key learning demonstrated by their projects.



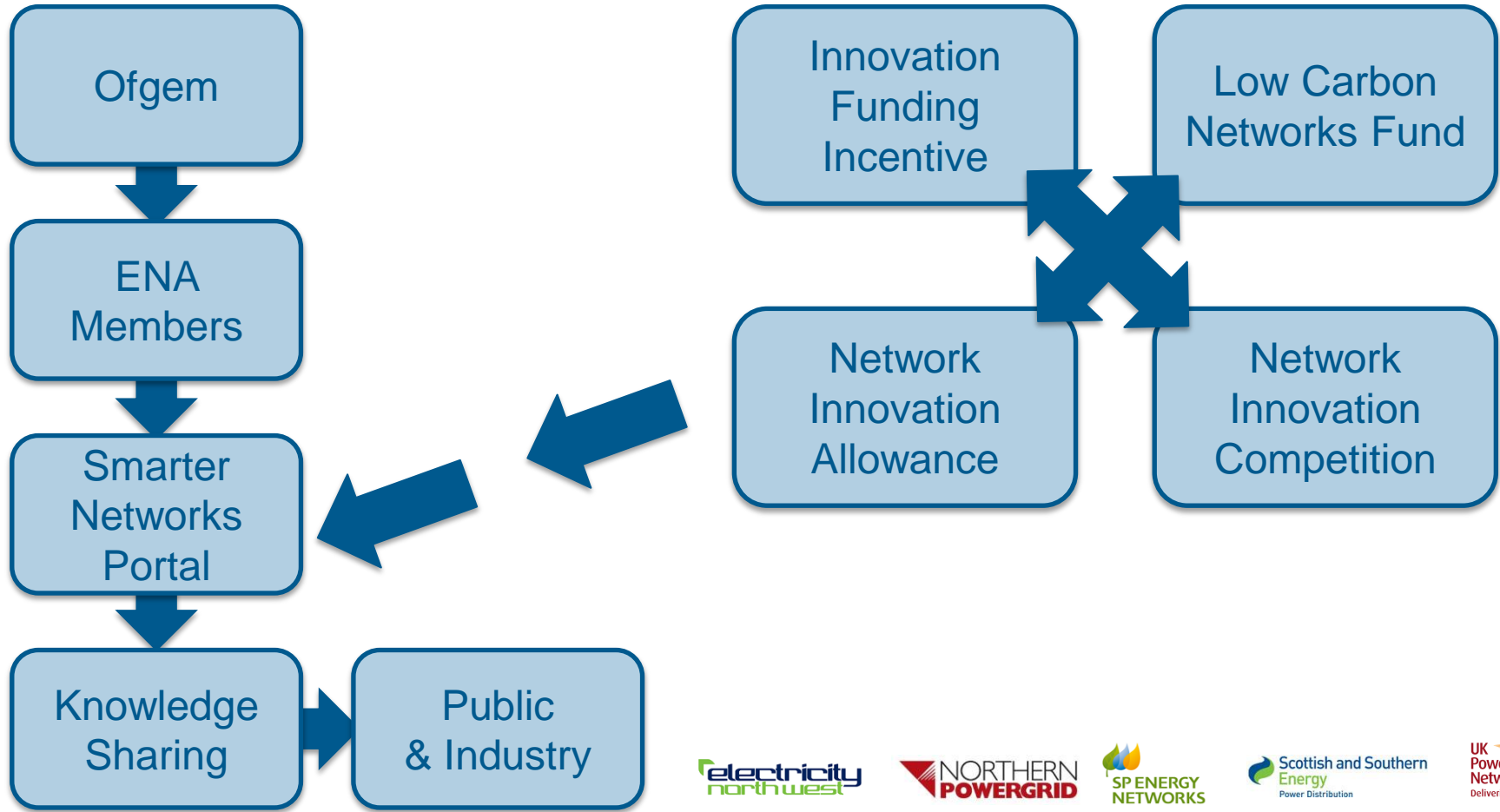
Why share knowledge?

The benefits are clear:

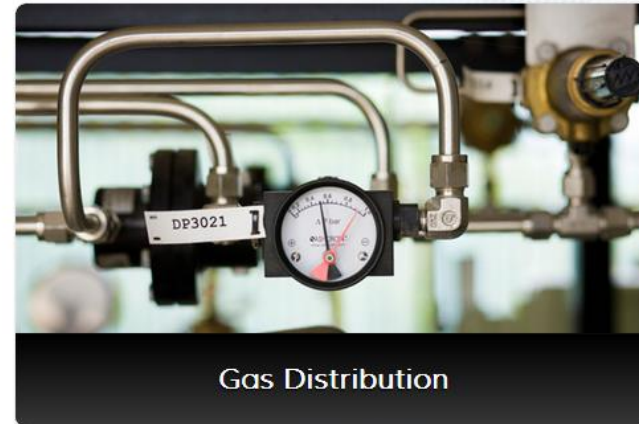
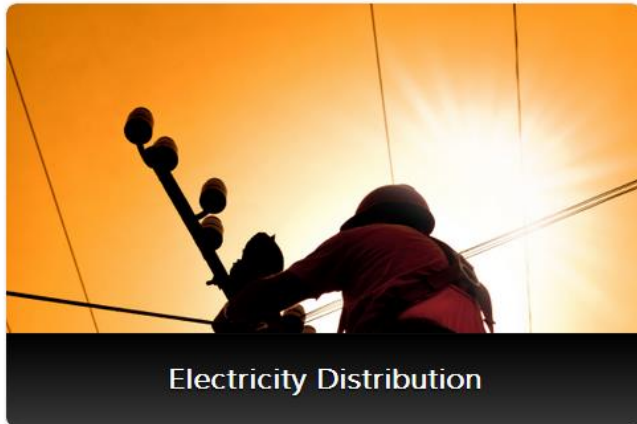
Customer money provides a stimulus for innovation. As a result the benefit of such funding should be shared with customers and other network licensees...

The Smarter Networks Portal provides:

- An overview of the technical and commercial coverage of current smart grid projects in GB.
- Identification of activity areas and gaps.
- Informing the joint ENA/ERA (CUE) demand response work.
- An understanding of likely sources of Cost/Benefit data.
- Information of relevance to the next round of LCN Fund bids.
- Information of relevance to the next round of Price Controls.
- Assistance to ENA, its members and other interested parties in tracking progress of projects and promoting the sharing of information and learning.
- Links to Industry Collaboration Portal.

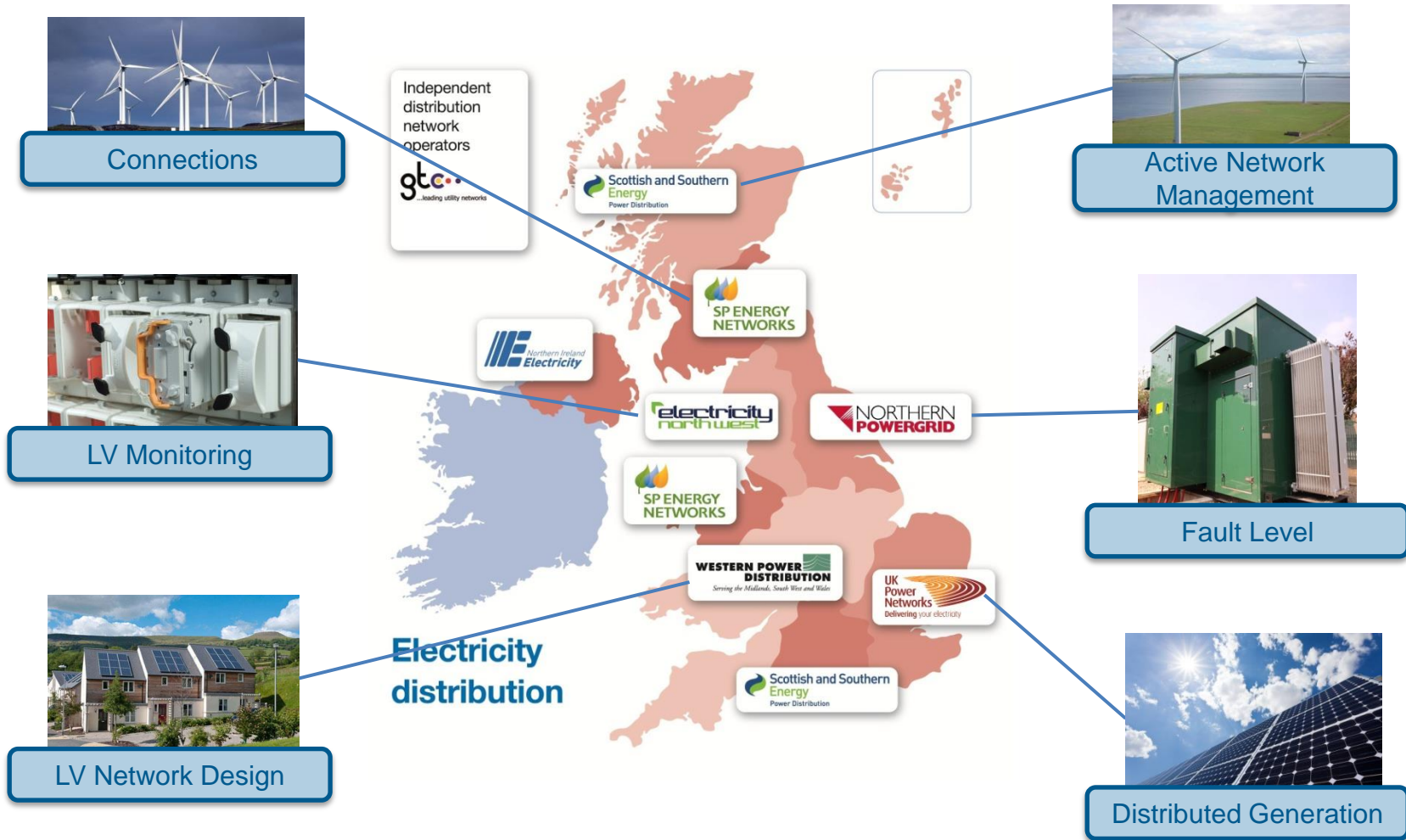
Annual conference – 2014 onward
